#### **Priorities for 2020-21**

- 1. Continued identification of underachieving PP pupils at each data drop closing the gap: all measures.
- 2. Extension of the Enrichment Programme (taking into account COVID-19 restrictions) to ensure that all pupils have access to expand their knowledge and understanding of Cultural Capital.
- 3. COVID-19 disadvantaged strategy.
- 4. Continued scrutiny of attendance data to inform interventions for persistently absence and late pupils across all year groups.
- 5. Early interventions from Secondary with Year 5/6 where we know behaviour for learning, attendance and punctuality are barriers to learning.
- 6. After school/holiday/weekend catch up including MyTutor, homework clubs and use of Teach First Mentors.
- 7. Use of internal teachers for cover rather than reliance on agency staff.
- 8. Ensuring all students have computer access to enable Blended Learning.
- 9. Implementing our Blended Learning Strategy.
- 10. Increased parental engagement.
- 11. Literacy and numeracy interventions.
- 12. SEMH support SaFE Workers; counsellor; mentoring.
- 13. Work experience and careers.
- 14. Weekly meetings to plan bespoke interventions for all year groups.
